## PERMISSION, RELEASE OF LIABILITY AND MEDICAL RELEASE

I, hereby expressly consent to my participation in the above named special event. I acknowledge that such participation includes but is not limited to, travel (public or private), preparation for competition, competition skiing, snowboarding, and snow-play at Pats Peak and other recreational facilities.

I understand that the sport of skiing/snowboarding, and other snow play activity involves inherent and other risks of INJURY and DEATH. In consideration of the right to participate in the above named event, I hereby release from any legal liability Pats Peak or any officer, affiliated organization, agent or employee for any injuries or deaths caused by or resulting from my participation in the sport of skiing/snowboarding, or any other snow play activity or use of the facilities (including chairlifts) of Pats Peak or in any way connected to my participation in the above named special event, whether such injury or death was caused by the alleged negligence of Pats Peak, another skier/snowboarder, or any other person or cause.

I further agree to defend and indemnify Pats Peak for any loss or damage, including any that results from claims or lawsuits for personal injury, death or personal property damage, related in any way to my participation in the above named special event or use of Pats Peak facilities.

I authorize any person connected with this event or with Pats Peak to administer first-aid to me as they deem necessary. I authorize medical and/or surgical care and transportation to a medical facility or hospital for treatment necessary for my well-being, at my expense.
